Dear Secretary Mayorkas,


The American Trucking industry has estimated that in 2021, we are living in one of the greatest shortage of qualified commercial drivers that will hit a historic number of over 80,000 operators needed. It is estimated in the coming years, left unchecked, we could see an unprecedented number of perishable commodities and medications discarded due to shelf life and/or expirations.

As you may know, over 71% of the US goods are moved by trucking entities. A bipartisan ACT presented by the Department of Homeland Security to Congress to allow a bill that would authorize grant money to used by the Hispanic Motor Carrier Association (HMCA) could present a solution to this shortage. This ACT would allow authorization for the HMCA to conduct vetting, archives, training, and duty assignments to trucking entities within our membership guidelines.

Those qualified could be B1/B2 holders or even H2b visa holders. Honorable Dr. Armando O' Cana, Mayor of Mission, Texas, has been instrumental in assisting the HMCA and has even offered a facility to conduct all business needs for this venture. In addition, South Texas College has also supported the idea of training should this proposal be granted.
