Subject: **O3 Worldwide, Inc. – USCIS Expedited Processing**

Dear Director Jaddou:

I write regarding O3 Worldwide, Inc. (“O3”) and O3’s objective to establish an EB-5 new commercial enterprise or enterprises to fund and develop within the scope of the national interest (1) aviation-related educational training and workforce development on a national basis; (2) sustainable aviation fuel (SAF) infrastructure and capabilities on a national basis; (3) air traffic management (ATM) systems on a national basis; (4) air transportation infrastructure and real estate on a national basis; and (5) an aircraft financing company to support and finance United States (U.S.) aircraft manufacturing and aircraft acquisition (hereinafter, individually and collectively, the “O3 Program”).

The O3 Program will begin in Florida with the establishment of Volare as an EB-5 new commercial enterprise focused on financing and developing commercial airline pilots for domestic and international airlines. Volare intends to invest billions of dollars in Florida, resulting in tens of thousands of Florida jobs, to be a model for workforce, housing, and economic development across the United States.

This project would be a decisive step toward addressing a nationwide shortage in the availability of commercial airline pilots, thereby strengthening national security and enhancing Florida’s and the nation’s ability to move people and goods across the country and worldwide efficiently.

I request that the United States Citizenship and Immigration Services (USCIS) review the adjudication of all USCIS benefit requests (such as an application or petition) made by the O3 Program, including, but not limited to, I-956, Application for Regional Center Designation; I-956F, Application for Approval of an Investment in a Commercial Enterprise; I-526E, Immigrant Petition by Regional Center Investor; I-485, Application to Register Permanent Residence or Adjust Status; and I-829, Petition by Investor to Remove Conditions on Permanent Resident Status.

O3 states that the Program is focused on addressing urgent national interests and will strengthen the U.S. commercial aviation market; finance traditionally underfunded air transportation infrastructure and real estate assets on a national basis; create tens of thousands of manufacturing, construction, and service jobs on a national basis; and improve the competitiveness of the U.S. in the global economy.

I ask for your full and fair consideration of their application, consistent with applicable agency guidelines. Please contact me at (202) 225-3001 if you have further questions.
