George Mason attended the Constitutional Convention, but he did not sign the Constitution.

One reason that George Mason did not sign the Constitution is that he believed the Constitution should have a <u>Bill of Rights</u>.

A Bill of Rights is a document that lists the rights that individuals have.

## **Passage of the Constitution**

After the Constitution was signed, the supporters of the Constitution had to convince other people in the United States to approve it.

John Jay, James Madison, and Alexander Hamilton were the writers of the Federalist Papers. They wrote the Federalist paper to support the passage of the <u>U.S.</u>
Constitution.



## Amendments and the Bill of Rights

George Mason convinced James Madison that the Constitution should be changed to include a Bill of Rights.

Each amendment in the Bill of Rights identifies different <u>rights</u> or freedoms for individuals. For example, **there are 5 rights or freedoms in the First Amendment:** 

- Speech
- Religion
- The Press
- Assembly (to gather)
- Petition the Government

The word "petition" means "to write to" or "to request."

"Petition the government" means that individuals have the right to make requests to the government or elected officials.

<u>Freedom of speech</u> and freedom of religion are examples of 2 rights of everyone living in the United States.

Once the Bill of Rights 1791 was added, George Mason supported the Constitution.

Many years before the Bill of Rights was added to the Constitution, George Mason wrote a document called the Virginia Declaration of Rights. Many of the rights that George Mason included in the Virginia Declaration of Rights were also included in the Bill of Rights.

This is why George Mason is known as the author of America's first Bill of Rights.


George Mason died in 1792, just 1 year after the Bill of Rights was added to the Constitution.

## **The George Mason Memorial**

The George Mason Memorial opened in 2002. It is one of four memorials located around the Tidal Basin.

The other monuments located around the Tidal Basin are the:

- Thomas Jefferson Memorial
- Franklin Delano Roosevelt Memorial
- Martin Luther King, Jr. Memorial



The George Mason Memorial is located closest to the Thomas Jefferson Memorial as a symbol of how important both men believed that individual rights, especially the freedom of religion, are to people.
