# Overview



- July 10, 2023—Federal Register published notices for family reunification parole (FRP) processes for Colombia, El Salvador, Guatemala & Honduras.
- Aug. 11, 2023—Federal Register published notices that updated existing FRP processes for Cuba & Haiti.
- Allows eligible nationals from these countries and their immediate family members to be considered for parole into the United States for up to 3 years.
- By Invitation Only—Only available to petitioners with an approved Form I-130, Petition for Alien Relative.

# Definition of Terms



Term	Definition
<b>Petitioner</b>	A U.S. citizen or U.S. permanent resident in the United States whose <a href="#">Form I-130, Petition for Alien Relative</a> , was approved. *Only petitioners who receive an invitation can submit Form I-134A.
<b>Beneficiaries</b>	Family members for whom Form I-130 was filed and approved. Beneficiaries may receive parole under family reunification processes to enter the United States for up to 3 years.
<b>Principal beneficiary</b>	A family member for whom a petitioner filed Form I-130. This includes: <ul style="list-style-type: none"><li>• Unmarried sons and daughters of U.S. citizens.</li><li>• Spouses, children (under 21), and unmarried sons/daughters (21 or older) of permanent residents.</li><li>• Married sons and daughters of U.S. citizens.</li><li>• Siblings of U.S. citizens.</li></ul>
<b>Derivative beneficiaries</b>	A principal beneficiary's spouse and unmarried children under age 21. They may also be listed on the approved Form I-130.
<b>Add-on derivative beneficiary</b>	If principal beneficiary marries or has a child after USCIS approves Form I-130, their spouse or unmarried child under 21 may become an add-on derivative beneficiary and may be eligible for parole.

# FRP Requires an Invitation



- Family reunification parole is available ***by invitation only*** to:
  - Nationals of Colombia, Cuba, El Salvador, Guatemala, Haiti, and Honduras who are principal beneficiaries of an approved Form I-130, and their immediate family members.
  - Petitioners may submit Form I-134A on behalf of family members only if they receive a written invitation from the Department of State.
- Petitioners must submit Form I-134A within one year.

# Step 1: Petitioner Receives Invitation

- **Invitation:** An invitation will be emailed or mailed to petitioner who filed the approved Form I-130.
- **Instructions:** Invitation will explain how to be considered under FRP.
- **Identifying Number:** Each invitation will have an identifying number the petitioner must include in Form I-134A.
  - Petitioner must include identifying number for ***each beneficiary and derivative beneficiary*** listed on Form I-134A.

Dear Petitioner:

U.S. Citizenship and Immigration Services (USCIS) records indicate that you have an approved Form I-130, Petition for Alien Relative, which you filed on behalf of the beneficiary or beneficiaries listed above. Based on this approved Form I-130, the principal beneficiary listed above and their derivative family members may be eligible for the Family Reunification Parole (FRP) Process for Salvadorans.

Participation in the FRP Process for Salvadorans is voluntary. Each family should carefully consider the enclosed information, including the warnings, before deciding whether to initiate your family members' consideration for parole under the FRP Process for Salvadorans.

If you choose FRP processing, this invitation allows you to begin the process by filing Form I-134A, Online Request to be a Supporter and Declaration of Financial Support, on behalf of the principal beneficiary of your approved Form I-130 and their derivative family members. You must file Form I-134A and supporting documentation no later than 12 months from the date of this letter. There is no fee to file the Form I-134A.

## Step 2: Petitioner Submits Form I-134A





Petitioner submits Form I-134A online for each beneficiary through the USCIS online account.

- ❖ If someone other than the invited Form I-130 petitioner submits Form I-134A, we will not confirm it.

Eligibility requirements:

- Petitioner must show they can financially support the beneficiary.
- Petitioner may include co-supporters.
- Family must provide evidence of family relationships between principal beneficiary and derivative and add-on derivative beneficiaries in Form I-134A for each beneficiary.
- All evidence submitted must have a full certified English translation.
- Petitioner must clear background checks.

## Step 3: Beneficiary Submits Biographic Info

### Principal Beneficiary:

- If USCIS confirms Form I-134A, beneficiary receives email from USCIS on how to create a USCIS online account and the next steps in the process.
- Beneficiary confirms biographic information and attests to meeting eligibility requirements.
- Beneficiary gets a panel physician exam and then attests to completing medical requirements **after** the medical exam is complete.
- If a beneficiary attests to medical requirements before a panel physician completes their medical exam, the beneficiary **will be denied** travel authorization.


# Step 4: CBP One Mobile Application

- Enter biographic information.
- Provide passport scan.
- Submit live photo.

# Step 5: Advance Travel Authorization



- CBP will post travel authorization determination to beneficiary's USCIS online account. (The petitioner will not have access to the travel document.)
- Advance travel authorization is valid for 90 days.
- Beneficiaries must arrange and pay for their travel to U.S. Derivative beneficiaries must travel with or after the principal beneficiary.
- CBP makes final parole determination when beneficiary is processed at U.S. port of entry.
- A beneficiary must have a valid passport, or other acceptable documentation as described in invitation letter sent to petitioner.



# Step 6: Seeking Parole at U.S. Port of Entry

- CBP makes a final discretionary decision on whether to grant parole.
- Decisions are made on a case-by-case basis when beneficiary arrives and is processed at a U.S. port of entry.

## Step 7: Beneficiary is Paroled Into U.S.

- People granted parole are generally paroled into U.S. for up to 3 years.
- Parolees may apply for an Employment Authorization Document (EAD) by submitting Form I-765, Application for Employment Authorization.
- We encourage parolees to submit Form I-765 online at [my.uscis.gov](http://my.uscis.gov).
- If approved, EAD is valid for authorized period of parole.

# Who Is Eligible to Submit Form I-134A (Petitioners)

## Who can submit Form I-134A under FRP?

- U.S. citizens or lawful permanent residents who:
  - Submitted Form I-130 for a family member (the principal beneficiary) and USCIS approved it.
  - Received an invitation by mail or email to initiate the process as a supporter of the principal or derivative beneficiaries.

# Who Can Be a Beneficiary Under FRP?



To qualify for parole under FRP, a beneficiary must:

- Be outside the United States.
- Be the principal beneficiary (or derivative beneficiary spouse or child) of an approved Form I-130, Petition for Alien Relative.
- Be a national of one of the six countries in the FRP process, or a derivative beneficiary spouse or child of a principal beneficiary from one of those countries.
- Have a petitioning relative in the U.S. who received an invitation to be a supporter who then filed Form I-134A that USCIS confirmed.
- Not have already received an immigrant visa.
- Have an unexpired passport valid for international travel.

# Derivative Beneficiaries



- The principal beneficiary's spouse and unmarried children (under 21) are called derivative beneficiaries. They may also be eligible for parole under FRP.
- Petitioner must file Form I-134A for derivative beneficiaries at the same time they file Form I-134A for the principal beneficiary.
- Derivative beneficiaries are only eligible for travel authorization if CBP approves travel authorization to the principal beneficiary.
- If petitioner does not submit Form I-134A for principal beneficiary, or if USCIS or CBP determine the principal beneficiary is not eligible, their derivative beneficiaries will not be eligible.

# Who Is Not Eligible to be a Beneficiary?



Nationals from Colombia, El Salvador, Honduras, and Guatemala are ineligible for FRP if they:

- Entered the United States without inspection after July 10, 2023;
- Were interdicted at sea after July 10, 2023;
- Were ordered removed from U.S. within the past five years; or
- Are inadmissible based on a prior removal order.

# Updates to the Cuban and Haitian Family Reunification Parole Processes

- Aug. 11, 2023--DHS announced updates to the Cuban and Haitian FRP processes.
- These processes remain available on an invitation-only basis.
- They will follow the same steps as FRP processes for Colombia, El Salvador, Honduras, and Guatemala.
- The previous Haitian FRP process required that the underlying Form I-130 was approved by USCIS on or before Dec. 18, 2014. This requirement no longer applies.

# Filings Under Previous Cuban Family Reunification Parole (CFRP)



U.S. Citizenship

- USCIS will mail notices to petitioners who submitted Form I-131, Application for Travel Document, under the previous CFRP, where the Cuban beneficiary is waiting for an interview.
- Notice explains how they can participate in the updated FRP process for Cubans.
- If petitioner wants consideration under new FRP, they must submit Form I-134A, Online Request to be a Supporter and Declaration of Financial Support.
- Petitioner can also choose to continue with previous CFRP process. In this case, the petitioner does not need to do anything.



Petitioners can stay with previous CFRP process or switch to new FRP.

# Employment Authorization Document

- Certain noncitizens need to apply for Employment Authorization Document (EAD) to work legally in U.S.
- An EAD can be used as proof of your identity and authorization to work.
- When you apply for an EAD, you can also request a Social Security number to get a Social Security card.



Some immigration benefits that involve a temporary stay in the United States require U.S. Citizenship and Immigration Services (USCIS) to determine whether the applicant or beneficiary of the request has sufficient financial resources or financial support to pay for expenses during the temporary stay. The individual who submits Form I-134A must establish that they have both sufficient financial resources and access to those funds to support the beneficiary listed on Form I-134A for the duration of the beneficiary's stay in the United States.

**⚠** We are only accepting online filing of Form I-134A from individuals agreeing to financially support eligible beneficiaries from the following countries:

- Colombia
- Cuba
- El Salvador
- Guatemala
- Haiti
- Honduras
- Nicaragua
- Ukraine
- Venezuela

You must be located in the United States to file Form I-134A online. Individuals seeking parole through these processes may not file Form I-134A on their own behalf. Supporters must include the name of the beneficiary on Form I-134A.

**Supporters must file a separate Form I-134A for each beneficiary they are planning to support, including minor children.**

To be eligible for this process, children under the age of 18 must be traveling to the United States in the care and custody of their parent or legal guardian and be able to provide documentation to confirm the relationship.

If you are agreeing to support a beneficiary who is not seeking consideration for parole under one of these programs or processes, you must file a [paper Form I-134](#) through the appropriate Lockbox location.

# How Will You Support Your Beneficiary

# Evidence

- Form will ask for evidence.
- Read each prompt and upload documents.
  - ❖ For example:
    - If you said you are a U.S. citizen, upload proof of U.S. citizenship.
    - If you listed assets in a savings account, upload your bank statement.
    - If you said you are married, upload proof of your marriage.
- All evidence submitted in a language other than English must have a certified English translation.
- Pay attention to file rules.

**Bank Officer Statement**

Provide a statement from an officer of the bank or other financial institutions with deposits, identifying the following details:

- Date account opened
- Total amount deposited for the past year; and
- Present balance.

As the person who agrees to financially support the beneficiary, you must show you have sufficient income or financial resources to support the beneficiary. Failure to provide evidence of sufficient income or financial resources may result in the denial of the foreign national's application for a visa or his or her removal from the United States.

**file requirements**

- Clear and readable
- Accepted file formats: JPG, JPEG, PDF, TIF or TIFF
